- a) Candidates should have completed the age of 17 years at the time of admission or should complete the age as on 31st December of the year of admission. Upper Age Limit 25Years.
- b) Candidates must have passed in H.Sc., (or) its equivalent examination with Physics, Chemistry, Biology & English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination mentioned above for unreserved candidates and 40% marks in respect of SC/ ST/OBC Classes.
- c) Candidates should obtained the eligible Percentile score in the NEET (UG) 2020 conducted by the NTA, New Delhi.

- b) The candidate should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.
- c) i) Candidate without original certificates / documents shall **not** be allowed to take admission in the allotted Homoeopathic Medical College.

- b) **Allotment letter given by the AYUSH Admissions Central Counseling Committee for admission is subject to fulfillment of all eligibility criteria prescribed by the CCH and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the AACCC. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund of fee, disciplinary rules and hostel rules etc.
- d) All the disputes/arbitration arising in the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University) and Vice-Chancellor's decision shall be final and binding.

NOTE:

- iii) 12th Pass Certificate (in case of CBSE or ISCE) or High School Diploma Certificate
- iv) Accreditation details of School & Numerical conversion of Grades into marks
