- a) Candidates who have been allotted through centralized counseling by the AACCC, **(AYUSH Admissions Central Counseling Committee)**, Ministry of AYUSH, Govt. of India, New Delhi for admission to **MD (Homoeopathy)** Programme in the Deemed to be University for the academic year 2020 - 21, are advised to report and complete the admission process within the date and time specified in the "Allotment Letter" issued by the AACCC.

- b) The candidates should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fee or UTR Number for **Electronic Fund Transfer through RTGS** as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Homoeopathic Medical College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute / College / University" shall **not** be allowed to take admission in the allotted Homoeopathic Medical College.

- b) **Allotment letter given by the AACCC**, Ministry of AYUSH, Govt. of India, New Delhi for admission is subject to fulfillment of all eligibility criteria prescribed by the CCH and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the AACCC. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund of fee, disciplinary rules and hostel rules etc.
